## RURAL WATER DISTRICT #4, GARVIN CO., OKLAHOMA AMENDED MINUTES OF BOARD OF DIRECTORS MEETING JANUARY 25, 2024

**DR. KIM JONES** called the meeting to order and took roll call.

**DR. KIM JONES** verified that the Board is in compliance with the State Open Meetings Act.

**EVERETT** made a motion to accept the minutes from **DECEMBER 2023**, **DEBY** seconded. all approved. None opposed.

## NO EXECUTIVE SESSION WAS REQUIRED AT THIS TIME

**ENGINEER REPORT BY MIKE KELLY: Mike** brought information packets back for all board members to review for an **ACCU-TAB CHLORINATION SYSTEM** to be installed for **RWD #4.** They operate like chlorine pool tabs for a swimming pool. The small system starts at \$7500 and the larger system \$12,000. Mike has suggested along with Jerry that together they need to set up a RESIDUAL STUDY FOR CHLORINATOR TESTING SITES first, and Jerry will test at the same time every day. Mike will get back to us with the cost of the study. The final system would have to be put in something that won't corrode such as a Rubbermaid tub for example. Mike will be able to run a deficiency test on the sampling sites to see where the Chlorination System is needed. Anything over 4.0 is too strong of chlorine. We will have to apply for a permit to install this system.

**EVERETT** made a motion to approve the financial statement, **DEBRA** seconded. All approved. None opposed.

**DEBRA** made a motion to approve the bills, **EVERETT** seconded. All approved. None opposed.

**<u>OLD BUSINESS</u>**: **<u>DEBRA</u>** made a motion to decide on menu from Tammy D's for annual meeting Feb. 26, 2024.
